Waiver Liability

Bidvest Car Rental provides liability waivers for the renter against financial loss; namely Collision Damage Waiver (CDW) & Theft Loss Waiver (TLW) – STANDARD COVER or Super Collision Damage Waiver (SCDW) & Super Theft Loss Waiver (STLW) - SUPER COVER.

CDW - In the event of an accident where the vehicle is damaged or written off, the liability of the renter is limited to the liability as set out in the WAIVER table under "Standard Liability" irrespective of fault or cause.

SCDW - In the event of an accident where the vehicle is damaged or written off, the liability of the renter is limited to the liability as set out in the WAIVER table under "Super Liability" irrespective of fault or cause.

TLW - In the event of theft, hijacking or loss of the vehicle and/or any accessories, the liability of the renter is limited to the liability as set out in the WAIVER table under "Standard Liability" irrespective of fault or cause.

STLW - In the event of theft, hijacking or loss of the vehicle and/or any accessories, the liability of the renter is limited to the liability as set out in the WAIVER table under "Super Liability" irrespective of fault or cause

This is provided that the renter is not in breach of any provision of the rental agreement.

Incidents specifically EXCLUDED from waiver liability & the renter is fully liable for any such damage caused to the vehicle:

- * Damage to tyres; windscreen & glass if no theft or collision of the vehicle has occurred
- * Damage caused by pot holes, dust storms, hail, gravel and or sand roads
- * Undercarriage damage and water damage

NOTE: Personal property; third party property/apparel is not covered by liability waivers.

NOTE: Towing is for the renters account

NOTE: Accidents/ theft must be reported to the nearest police station within 24 hours; all incidents must be reported to Bidvest Car Rental within 48 hours. Renter must complete all required documentation.
